
Sir,

In continuation of this Ministry's sanction letter of even No. dated 06.05.2016, I am directed to convey the Sanction of the President for payment of grant of **Rs. 26,99,250/-** (Rupees Twenty Six lakhs Ninety Nine Thousand Two Hundred Fifty Only) as 3<sup>rd</sup> and final installment of non-recurring grant for museum related components during the current financial year 2018-2019 to the Bright Future Society, Ziro, Lower Subansiri District, Arunachal Pradesh for meeting the expenditure as details given below:-

- i) The utilization certificates in respect of the grant to the effect that the grant has been utilized for the purpose for which it was sanctioned duly signed by Chartered Accountant should be furnished to this office within 12 months of the closure of the financial year of the release of this installment covering the matching share of the organization also, failing which the organization is required to refund the amount already drawn under the scheme, to the Ministry of Culture, New Delhi with a penal interest of 10% per annum.
- ii) The grant will be drawn by the Drawing & Disbursing Officer (GIA), Ministry of Culture and paid to Bright Future Society, Ziro, Lower Subansiri District, Arunachal Pradesh for their proposal for Setting up of Mumpa Museum, Ziro, Arunachal Pradesh by means of Electronic Transfer to their A/c No. 33904037258 at State Bank of India, Branch of Ziro, Arunachal Pradesh
- iii) Misutilization of funds or non-submission of UC in time will be viewed seriously and the defaulter organization will be black listed and debarred from receiving future grants from Govt. of India, as well as appropriate action under the law would also be taken by the Government.
- iv) **It is certified that no Utilization Certificate is pending in respect of previous grant/grant(s).**
- v) **It is certified that the grantee has utilized more than 80% of previous installment released by the Central Government as well as their proportionate matching contribution.**
- vi) You should install Rooftop Solar system and take concrete steps by calculating the available area and the power generation envisaged.
- vii) The expenditure will met from Demand No. 18, Ministry of Culture, Major Head 2205, Minor Head 00.107- 41, Development of Museums – Museum Schemes - 01.35 - Grants for Creation of Capital Assets (Revenue) Non-recurring for the year 2018-2019 **(Under NE Provision)**.
- viii) This sanction is issued in exercise of the delegated powers and in consultation with IFD vides their Dy. No 4639 dated 11.07.2018. It is certified that the pattern of assistance under the above scheme has the prior approval of the Ministry of Finance, Government of India. It is certified that this grant is being released in conformity with the rules and the principles of the scheme.
