

**Addendum to e-Tender Request**

Attention may be drawn to the advertisement issued on 14.11.2018 inviting sealed bids to conceptualize, design, fabricate and display a Tableau of Ministry of Culture during Republic Day Parade, 2019, on the theme 'Mahatma Gandhi'. In this regard, in pursuance to the suggestions made in the pre-bid meeting on 19.11.18, para 15.1.2 of the bid document, as available on the CPP portal '<https://.eprocure.gov.in/>/[www.indiaculture.gov.in](http://www.indiaculture.gov.in)', is amended to the extent that the average annual turnover is reduced from Rs.2 crores to Rs.1 crore. Other consequential provisions are also treated as accordingly. Para 4.4 of the bid document, is also modified to the extent that, in terms of the provisions under the General Financial Rules, 2017, the EMD amount of Rs.50,000/- from Micro and Small Enterprises (MSME), as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises MSME or registered with the Central Purchase Organisations or the concerned Ministry or Department will not be required. Other consequential provision(s), if any, are also treated as modified accordingly.

It is also conveyed that the last date for **submission** of the bids will be till **12 Noon of 29.11.2018**, instead of earlier scheduled date of 27.11.18 by 3.00 P.M. The **technical bids** will now be open on **29.11.2018 at 5.00 P.M.**, instead of earlier scheduled date of 27.11.2018 at 3.00 P.M.
