2. The expenditure will be met from Demand No.18-Ministry of Culture, Major Head '2205' Art & Culture Minor Head **00.102.11.01.31** under the "**Kala Sanskriti Vikas Yojana (Schemes and Missions)**" Grant-in-aid-- General **2018-2019** (Non recurring) for the financial year **2018-2019**.
3. The grant will be drawn by the Drawing & Disbursing Officer (Grants), Ministry of Culture and paid to the organization by means of **RTGS**.
4. This is non-recurring grant in nature and it is being released after fulfilling the conditions prescribed in GFR Rule.
