The National Monuments Authority (NMA) is a statutory body constituted under the provisions of Ancient Monuments and Archaeological Sites and Remains Act, 1958 with the following objectives:-

- a) make recommendations to the Central Govt. for grading and classifying protected monuments and protected areas declared as of national importance under sections 3 and 4, before the commencement of the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Act, 2010;
- b) make recommendations to the Central Govt. for grading and classifying protected monuments and protected areas which may be declared after the commencement of the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Act, 2010, as of national importance under section 4;
- c) oversee working of the competent authorities;
- d) to suggest measures for implementation of the provisions of this Act;
- e) to consider the impact of large – scale developmental projects, including public projects and projects essential to the public which may be proposed in the regulated areas and make recommendations in respect thereof to the competent authority;
- f) to make recommendations to the competent authority for grant of permission.

It is proposed to fill up 04 vacant posts of Part Time Members in the National Monuments Authority. A copy of the circular issued in this regard is attached. The eligibility criteria and Terms & conditions of the appointment have been given in the circular.

You are requested to send nominations of suitable person/persons as per the eligibility criteria to the undersigned alongwith Curriculum Vitae within 10 days of issue of this circular i.e. 7th August, 2019 till 5.30 pm.



**INVITING NOMINATIONS FOR APPOINTMENT AS PART TIME MEMBERS OF THE
NATIONAL MONUMENTS AUTHORITY**

Applications are invited from the eminent professionals with proven experience and expertise in the fields of Archaeology, Country and Town Planning, Architecture, Heritage, Conservation-Architecture or Law for appointment as Part Time Members (04) of the National Monuments Authority (NMA), a body constituted under the Ancient Monuments and Archaeological Sites and Remains Act, 1958 by the Central Govt.

- a) The Part Time Member shall be eligible for sitting allowance of Rupees five thousand for each day he/she attends the meeting of the Authority but not exceeding Rs. 50,000/- in a month and shall be entitled to reimbursement of transportation charges at the rates as admissible to Whole Time Member.
- b) The tenure of Part Time Member shall be three years from the date on which he/she assumes office as such.
- c) Any person who has held any post in the Archaeological Survey of India or in the Ministry of Culture of the Govt. of India or a State Govt. or has not been found fit to be considered for being appointed to any such post, shall not be eligible to be appointed as a Member of the Authority
- d) Any person, who had either been granted a permission or license or refused any such permission or refused grant of a license or any person or any of his/her relative having any interest in a prohibited area or a regulated area shall not be eligible to be appointed as a Member. For the purpose, "relative" means:-
 - i) Spouse of the Member of the NMA;
 - ii) Brother or sister of the Member of the NMA
 - iii) Brother or sister of the spouse of the Member of the NMA;
 - iv) Brother or sister of either of the parents of the Member of NMA;
 - v) Any lineal ascendant or descendant of the Member of the NMA;
 - vi) Any lineal ascendant or descendant of spouse of the Member of the NMA;
 - vii) Spouse of the person referred to in clauses (ii) to (vi),
- e) The person so appointed to function as a Part Time Member, should not be of the age more than 67 years. The maximum age limit of 70 years shall apply for retirement to the incumbent to these posts.
