Person of the highest level of competence, integrity, moral and institutional commitment shall be appointed as Vice Chancellor. The Vice Chancellor to be appointed shall be a distinguished academician with a minimum of ten years of experience as Professor in a University system or ten years of experience in an equivalent position in reputed research and /or academic administrative organization.</p> <p>Desirable Qualification</p> <ol style="list-style-type: none"><li>Doctorate Degree in Buddhist Studies/ Buddhist Philosophy/Pali from a recognized university</li><li>Knowledge and fluency in written and spoken Hindi and English Languages.</li><li>Evidence of outstanding research and published works in national/international journals of repute or as well acknowledged books in the field of Buddhist Studies.</li></ol> <p>Upper age limit for applying: Not exceeding 55 years on the closing date of receipt of applications</p> <p><b>Short Term contract:</b></p> <p>Qualification: As prescribed for deputation</p> <p>Upper age limit for applying: Not exceeding 65 years.</p> <p>Note:</p> <ol style="list-style-type: none"><li>The Vice-Chancellor shall hold office for a term of 5 years.</li></ol>

The period of deputation including the period of deputation in any other ex-cadre post held immediately preceding this appointment in the same or some other organisation / department of the Central Government shall ordinarily not exceed 5 years.</p>
